**MARCH**

- All unpaid 2021 property tax must be paid by March 31 in order to avoid delinquent penalties on April 1
- The fourth and final 2021 installment property tax bill is due by March 31
- A property that is being rented out for six months or less must have a tourist development tax account
- As a reminder, online rental platforms (Airbnb, VRBO, etc.) DO NOT remit the 5% tourist development tax to our office. It is the homeowner's responsibility to ensure the tax has been remitted
- A local business tax is required for ALL property rentals, regardless of how long they are being rented
- We now accept Apple Pay in all of our office lobbies, and we also accept PayPal for online transactions.

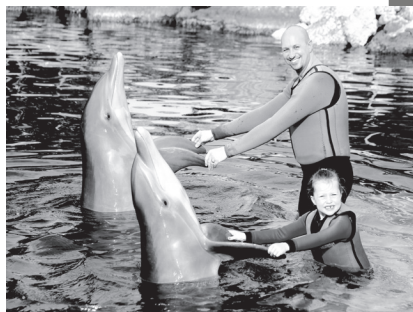
**MEMBER SPOTLIGHT**
